GLOSSARY OF TERMS

Activities of Daily Living (ADLs)

Basic self-care including bathing, dressing, grooming, toileting, eating, and other personal care tasks. ADLs do not include cognitive (thinking/ processing) abilities.

Alzheimer Dementia Special Care License

A license issued to an assisted living residence that has been physically adapted to accommodate the needs and behaviors of those with significant memory-loss. This license requires increased staffing, appropriate therapeutic activities, and staff training on the effective management of the physical and behavioral issues common to people with Alzheimer's disease. Residents in this level have been medically evaluated, have a diagnosis of Alzheimer's disease or other related dementia, and a physician's recommendation for this level of care.

Activities of Daily Living (ADLs)

Basic self-care functions including bathing, dressing, grooming, toileting, eating, walking or wheeling, and transferring into and out of bed, and other personal care tasks.

Aging in Place

Concept which advocates allowing a resident to choose to remain in his/her living environment despite the physical and or mental decline that may occur with the aging process of aging.

Assisted Living Residence (ALR)

Assisted Living provides a combination of housing, personal assistance, supportive services, and health-related care. This residential option caters to individual needs by promoting dignity, independence, privacy, and autonomy while protecting the safety and health of residents. Assisted living encourages quality of life for all residents in a home-like environment. Assisted Living may not be appropriate for those with severe cognitive issues, behavioral issues, limited mobility (bed-bound), or for those who require ongoing nursing care.

Independent Living (IL)

Independent Living is for seniors who require little or no assistance from a caregiver. These are classically known as retirement homes. Independent living communities are best for seniors who do not require supportive services or assistance with activities of daily living.

Instrumental Activities of Daily Living (IADLs)

Day-to-day tasks such as preparing meals, shopping, managing money, taking medication, laundry and housekeeping.

Limited Health Services (LHS) License

A higher level of assisted living licensure that allows additional nursing services to be provided to residents whose needs do not reach the level of skilled nursing. Staff providing direct care services shall be either a nurse or a registered nursing assistant.

Long-Term Care (LTC)

Care given in the form of medical and support services to someone who has lost some or all their capacity to function due to an illness, injury, or disability.

Ombudsman

Often a volunteer representative who handles complaints of residents and families and works to resolve any problems or differences with the facility staff by defining concerns, explaining rights and identifying choices. An ombudsman can help resolve the problem in most cases; however, complaints involving serious abuse or neglect are referred to the appropriate agency.

Medicaid

Public assistance funded by individual states and the federal government for people who have disabilities and/or are low income. In Rhode Island, Medicaid-covered assisted living services are limited.

Medicare

A U.S. federal health insurance program for people 65 years and older. Medicare does not cover assisted living services.

Personal Assistance

Providing one or more services: assisting residents with personal needs including activities of daily living, assistance with administration or self-administration of medication, providing or assisting in arranging health and supportive services, monitoring activities of residents on the premise to ensure health and safety, and promoting recreational, social, or personal services.

Respite Care

Scheduled short-term skilled nursing-level care provided on a temporary basis to an individual who needs this level of care but who is normally cared for in the general community.

Skilled Nursing Home (SNF)

Nursing homes are licensed as Skilled Nursing Facilities. This healthcare option is designed to provide 24-hour skilled care for seniors with health conditions that require medical and nursing care. Individuals in this setting usually require assistance with all activities of daily living.

Fire Code: Fl licensure

For residents who are not capable of using physical mobility or judgmental ability to take appropriate action and require assistance during emergency situations.

Fire Code: F2 licensure

For residents who have the physical mobility or judgmental ability to take appropriate action during emergency situations without assistance.

Medication Code: M1 licensure

For residents who require storage and/or actual administration of medication

Medication Code: M2 licensure

For residents who might need a reminder but are able to self-administer medication
